

The Tisbury School Building Committee (TSBC) was called to order at 7:00PM. Chair Colleen McAndrews stated for the record that:

- the meeting was being video and recorded by MVTV and by a member of the public;

- recorder Ms. Marni Lipke was not present; and

- Mr. Jeff Kristal was participating by phone due to geographical distance and therefore all votes would be by roll call.

(Recorder's note: Occasionally the discussion is re-grouped for clarity and brevity.)

- The final Schematic Design with detailed cost estimates would be submitted in November. At this point costs and grant share were set and experience showed they

held steady throughout the remaining process.

- The Town then had 120 days to approve funding for the project, either with an April 2018 Annual Town Meeting or a Special Town Meeting vote. Failure at Town Meeting or the more common scenario of failure at the ballot would put the project into the MSBA "Failed Vote" process. The MSBA allowed 180 days to rethink and revote the project; however any further feasibility costs needed for this stage were the responsibility of the Town and the Town could possibly be left to pay for the entire project.

The TSBC debated a number of issues.

- The MSBA set certain standards, e.g. minimum classroom size based on 25 a student average. The FAS was most likely to challenge the Tisbury School class size (16-17 students) requiring two classrooms per grade. TSBC representatives, Daedalus and T2 would argue for this and possibly for slightly smaller classrooms to decrease square footage—the best cost reduction option. However, the MSBA was looking to fund the *right* size, taking into account learning habits of different ages, size of growing children, etc. A 2-3% reduction might be possible but not 5-10%.
- There was some dissatisfaction with the location of the new construction on the site:

lower grade than the road;

- crowding the neighborhood residences;

- siting only to allow use of the old building during construction;

unaesthetic/unsafe location of parking.

\* Amy Tierney entered the meeting.

Designer Peter Turowski explained that even if the site were blank he was drawn to situate the building where it was currently proposed. There were adequate setbacks, complex grading, and lower roof lines near abutters. The current building was artificially raised, now untenable for American Disability Act (ADA) access. All this could be addressed in the next design phase.

- There was disagreement on the severity of the impact of displacing education during construction. The Planning Board requested a work-up of partial demolition of the

current building during new construction (see documents on file).

• Options for renovation/addition design were clarified; the requirements to code, specific use of the old building, flexibility of steel (new construction) over masonry in current and future renovations.

• The project was designed with proper leaching wicks setbacks and there was a brief conversation on their placement, testing, watershed and depth (see below: Actions).

• Town Administrator Jay Grande stressed other Town infrastructure needing replacement or renovation: Town Hall, Police Station, Senior Center, Wastewater Treatment Facility, storm water drainage, Waterworks buildings, etc.

It was clear that everyone wanted what was best for the students and the Town.

 The Base Repair option, which did not address educational needs, had not been officially eliminated.

## IV. Authorize Submission of Preferred Schematic to MSBA

Chair Amy Houghton called the Tisbury School Committee (TSC) meeting to order.

#### II. Update on Options Design and Cost

(See documents on file.)

Turowski2 Architects (T2) presented the updates.

 Addition/Renovation: showed 80,000 sq. ft. of outdoor play area (structured, grass and paved); 80 parking spaces and 350 linear ft. for parent drop-off. The interior remained substantially the same as shown at previous meetings. The construction phase was estimated at 29 months with target completion in summer 2021—specific phasing available on request.

- A third party estimate came within 2-3% of the Owners Project Manager (OPM) Daedalus Projects estimate at about \$47,500,000 [Town share \$34-35,000,000, Massachusetts School Building Authority (MSBA) funding \$15,600,000). Modulars were projected at \$800,000 to \$1,000,000. The MSBA renovation bonus was limited, in that it

only applied to the renovation part of the project.

• New construction showed 93,000 sq. ft. of play area, 95 parking spaces including the remote lot, and 300 linear ft. for drop off. Construction duration was projected at 25 months (later start) with target completion in summer 2021. The roofs were peaked to accommodate equipment and screen it from view.

- The estimates came to about \$45,000,000 [Town share ~\$33,100,000 (smaller building,

greater efficiency, elimination of modular), MSBA share ~\$14,000,000].

### III. Vote on Preferred Schematic

The somewhat complex MSBA process was outlined.

- The MSBA Board met every two months and required 7 weeks to review submissions. This meant that a delay of a day beyond a submission deadline would push a project back two months to the next MSBA Board meeting. The next Board meetings were:

August 23rd (submission deadline June 29th) for final approval December, 13th, and October 25th (submission deadline August 28th) for final approval February 2018.

- An MSBA Feasibility Assessment Subcommittee (FAS) was formed for each project. The Board had a history of approving all FAS recommendations.

- The TSBC would vote a single option, hopefully by the June 29th submission date and

the FAS would consider all aspects and vote a recommendation. - Meanwhile the designer/architects and OPM would begin the more detailed design

process on building location, educational programing, landscaping, etc.—within the chosen option there was considerable flexibility.

- ON A MOTION DULY MADE BY MR. DE BETTENCOURT AND SECONDED BY MS. COOGAN THE TISBURY SCHOOL BUILDING COMMITTEE UNANIMOUSLY VOTED TO ELIMINATE THE BASE RENOVATION FROM CONSIDERATION; 16 AYES, 0 NAYS, 0 ABSTENTIONS: MS. COOGAN—AYE, MR. DESORCY—AYE, MR. - This had been a lengthy process including in the last year: 7 forums, 2 surveys and a large number of meetings with Daedalus, T2 and the TSBC participation, due diligence on 5 sites, a month's notice given on all TSBC votes and a month's delay of this Preferred Schematic vote. However, there had been feedback from two Town Boards on feeling rushed. Chair McAndrews requested that people contact the Chair on what further information was needed to make a decision.
- Deferral of the decision, pushing submission to the next MSBA Board meeting would:
   + require the TSBC to meet during the summer when quorums were difficult to get;

+ force a rush to vote at the April 2018 Town meeting; and

+ push completion to October 2021.

- In addition construction costs were inflating at 5% per year compounded, causing the

project cost to increase ~\$393,000 for each two-month delay.

- The Chair requested a straw poll on whether TSBC members were ready to vote on the decision. The poll was unanimous that all were ready: MS. COOGAN—AYE, MR. DESORCY—AYE, MR. MULVEY—AYE, MS. - There were two public comments:

- one confirming that design aspects were not set at this phase; and

- one advocating for a delay to insure Town support.

• A MOTION DULY MADE BY MS. MULVEY AND SECONDED BY MR. DE BETTENCOURT TO SUPPORT THE EDUCATIONAL NEEDS OF THE STUDENTS AND RESPECT THE WISHES OF THE STAFF TO BUILD A THREE STORY NEW

CONSTRUCTION ON THE CURRENT SITE WAS MODIFIED BY REQUEST.

• ON A MOTION DULY MADE BY MS. MULVEY AND SECONDED BY MR. DE BETTENCOURT THE TISBURY SCHOOL BUILDING COMMITTEE VOTED TO BUILD A NEW THREE-STORY SCHOOL AT THE CURRENT SITE; 11 AYES, 5 NAYS, 0 ABSTENTIONS: MS. COOGAN—AYE, MR. DESORCY—AYE, MR. MULVEY—AYE, MS. MULVEY—AYE, MS. MULLIN—AYE, MS. BACHELLER—AYE, MS. TIERNEY—NAY, MS. MCANDREWS—AYE, MR. KRISTAL—AYE, MR. CUSTER—AYE, MR. DE BETTENCOURT—AYE, MS. MILNE—AYE, MR. SEIDMAN—NAY, MS. LOBERG—NAY, MS. DOBLE—NAY, MR. GRANDE—NAY. Selectman Melinda Loberg qualified her vote as based on a previous Board of Selectmen vote rather than current information.
